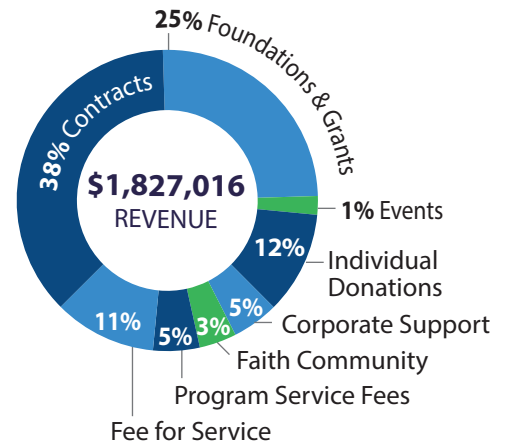
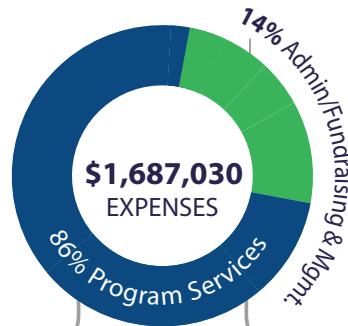


545 Men, Women & Children impacted by incarceration, were supported by CCT in FY2020, through the following programs:
